

Warranty Statement

GREENHECK GROUP* ("WE," "US," OR "OUR") WARRANTS ITS PRODUCTS TO BE FREE FROM MATERIAL DEFECTS IN WORKMANSHIP AND MATERIALS FOR A PERIOD OF ONE (1) YEAR (OUR "BASE WARRANTY"). THIS BASE WARRANTY COMMENCES ON THE SHIPMENT DATE (THE "COMMENCEMENT DATE").

DURING THE BASE WARRANTY PERIOD, WE WILL PROVIDE THE REPLACEMENT PARTS NECESSARY TO CORRECT ANY MATERIAL DEFECTS IN OUR WORKMANSHIP AND MATERIALS. THE BUYER ("YOU" OR "YOUR") IS RESPONSIBLE FOR ALL OTHER COSTS OF CORRECTING ANY DEFECTS, INCLUDING, WITHOUT LIMITATION, COSTS ASSOCIATED WITH LABOR, INSTALLATION, REMOVAL & DISPOSAL, SHIPPING, HANDLING, CRATING, AND INSURANCE. OUR PROVISION OF REPLACEMENT PARTS DOES NOT LENGTHEN THE WARRANTY PERIOD.

THIS BASE WARRANTY EXPRESSLY EXCLUDES:

- CONSUMABLE PARTS AND SUNDRIES SUCH AS BELTS, CHAINS, LIGHT BULBS, REFRIGERANT, FLUIDS, FUSES, FILTERS, DESICCANTS, O-RINGS, MOTOR BRUSHES, GLASS, GASKETS, SEALS, AND LUBRICANTS;
- DEFECTS THAT DO NOT MATERIALLY AFFECT THE PRODUCT'S ABILITY TO MEET ITS STATED PERFORMANCE SPECIFICATIONS;
- DAMAGE TO THE PRODUCT, PERFORMANCE DEFICIENCIES, OR DEFECTS CAUSED DURING SHIPMENT, TRANSIT, INSTALLATION, STORAGE, ON-SITE CONSTRUCTION, OR MAINTENANCE;
- DAMAGE TO THE PRODUCT, PERFORMANCE DEFICIENCIES, OR DEFECTS CAUSED BY MISUSE, FAULTY MAINTENANCE OR SERVICE, FAILURE TO FOLLOW OUR PRESCRIBED INSTALLATION, MAINTENANCE, STORAGE, AND SERVICE SCHEDULES AND RECOMMENDATIONS, USE OF NON-GREENHECK GROUP PARTS, AND/OR YOUR SERVICE OR REPAIR TECHNICIANS;
- DAMAGE TO THE PRODUCT, PERFORMANCE DEFICIENCIES, OR DEFECTS CAUSED BY EVENTS OR
 CONDITIONS OUTSIDE OUR CONTROL, INCLUDING, WITHOUT LIMITATION (i) ACTS OF GOD, (ii)
 WEATHER CONDITIONS, (iii) CORROSIVE OR NOXIOUS ELEMENTS, FUMES, CHEMICALS, SALTS,
 OR OTHER SUBSTANCES, (iv) VOLTAGE FLUCTUATIONS OR FAULTY ELECTRICAL, AIR, WATER, OR
 FUEL SUPPLY, (v) LIGHTNING, FREEZING, SAND/DUST STORMS, SMOKE, FIRE, RAIN, HAIL, WIND,
 FLOODING, STANDING, POOLING, OR PONDING WATER, AND (vi) AND GALVANIC CORROSION,
 AND (vi) USE OR ADDITION OF THIRD-PARTY COMPONENTS;

OTHER THAN OUR OBLIGATION TO PROVIDE REPLACEMENT PARTS TO YOU UNDER THIS BASE WARRANTY, WE SHALL NOT BE LIABLE UNDER THIS WARRANTY FOR ANY LOSS, INJURY (INCLUDING BODILY INJURY AND DEATH), OR DAMAGE TO ANYONE OR ANYTHING ARISING OUT OF, ASSOCIATED WITH, RELATED TO, OR CONNECTED WITH ANY DEFECTS ASSOCIATED WITH THE PRODUCT.
