CAPS® 4.36 will be released Monday, August 2 at 3:00 p.m. CDT

The following information highlights the new products and enhancements in this release.

United States Manufactured New and Enhanced Products

Power Roof Ventilators (PRVs)

- Speed controllers have new option to ship with unit
- Replace A Fan Tool curb adapter workflow updates
- Added submittal info (MCA, MOP, SCCR and FEI)
- Roof curb models GPIR and GPFR can have a damper tray when selecting 'stand-alone'
- Models with old nomenclature no longer can be ordered and must be reselected
- Match color chip pricing revamped
- Additional Vari-Green® selections 1, 2, and 3 horsepowers (CUE-140HP, 160XP, 180HP, 200, 200HP, 240...)

Axial and Inline Fans

- Models SQ/BSQ have fan efficiency index (FEI) certification
- Some products changed pricing category in FV3 and FV5
- Match color chip pricing revamped
- Discontinued models RGU, LD, LDP, ESRMD/ESRMDF sizes 24/30, and two-speed induction motors

Ceiling Exhaust Fans (Bathroom Fans)

- Ceiling radiation damper (CRD) expansion available on SP-AP series sizes
- New minimum ventilation controller compatible with Vari-Green
- Added min/max fan curves for Vari-Green selections.

Centrifugal (Blowers and Plenums)

- Blower model USF, 100 series, Arrangement 4, direct drive, micro drive, added 0 to 10 volt control signal
- Blower model USF, arrangement 3 and 9 belt drive have been removed
- Discontinued the louvered supply fan, model LSF <u>See bulletin 29-21</u>

Fume Exhaust and Tubular Inline Fans

- New composite tubular inline QEID FJ-18 fan with Spark A, up to 3,000 cfm
- Added Spark B construction to models TBI-CA and TAUB-CA

High Volume Low Speed (HVLS) Fans

- Advanced touch screen controller can handle up to 20 fans
- Added UL-507 damp location certification
- Electrical warranty increased to three years (DC sizes 4-7)
- Added 20-foot power cable option

Dampers

- Curtain fire dampers mounting selection now available line by line
- New ABD-RB steel collar option
- Round control dampers can now have a bracket only option
- Updated UL listings for CFSD dampers
- Submittal notes for control dampers actuator sizing
- Heater control (SCR, Vernier SCR) updated for IDHE and IDHE-O to meet NEC requirements
- Discontinued models VCD-20V, VCD-42V, and VCDRM-50

Louvers

- New model EAD-632W for warehouse (extruded aluminum adjustable with drainable blades)
- Added prime coat and mill finish information submittal page
- Added GCC roof curb for louvered penthouse models WIH and WRH
- Removed pneumatic actuators from all adjustable and combination models

Kitchen Ventilation Systems (KVS)

- Product line simplification continuation (discontinued integral and short circuit supply hoods, 16-gauge material option, and KFCC/Variflow kitchen controls)
- Added help content for Greenheck controls
- Added optional updated fees based on zip code input for fire suppression field hookup child mark
- Moved gas valves to a child mark on fire suppression systems to allow for easier order processing and timing for shipments of gas valves.
- Report enhancements (increased accuracy of hood and accessory weights, and additional fire suppression details)

- Quick Build is no longer available with Packaged DX due to supply chain shortages
- All EC condenser fans are no longer available due to supply chain shortages

- Greenheat enhancements Added mixed flow selections and updated sizing calculations; see upcoming webinar for more details
- Expanded external VFD option for mixed flow housings H32 and H35
- Expanded airflow capacity in housing H32 from 16,000 cfm to 18,000 cfm
- Remote panel wiring diagram enhancements Added spaghetti diagram
- Updated mixed flow sound data
- Forward curve discontinuation has continued in H32 IGX units
- Base package offering continuation with NO new "DG" units to be selected except DG-PDX and DG-H05

- Replaced mixed flow fans with punker plenum fans (increased performance)
