SUBJECT: My Account New Feature - CAPS® Access in your Territory

We are excited to extend a new feature on My Account that allows you to see real-time site registrations by customers in your sales territory. This new area will replace the monthly emails with site registrations in your territory. This feature gives you visibility to all customer interactions in your territory and helps generate sales prospects or follow-ups for your business.

In the past, we have sent spreadsheets to a specific individual(s) at each office with any new registrations or CAPS requests and asked you to identify users who may be a competitor so we can restrict CAPS access. The new area will let specific office(s) allow or reject users in your territory access to CAPS interactively.

We will send out one last list of new customer registrations this week, then ask that you use the new page on My Account for this process.

Access this new feature by logging into your greenheck.com/My Account. Under Rep Resources, you will see a new widget titled *CAPS Authorizations*.
